### **Scams**

09.08 The victim stated she received a phone call from an unknown individual claiming to be a member of the Anoka County Sheriff's Office. The male claimed she missed jury duty and had a warrant for her arrest. She stated she was concerned about possibly going to jail because she had a young child to take care of and the caller sounded very convincing. During their conversation, she received multiple photos with instructions on how to clear her alleged warrant. She followed a QR code she was sent and was ultimately requested to send the funds via Bitcoin. She went to the nearest Bitcoin ATM as instructed by the caller, which happened to be at Go-For-It Gas in East Bethel. She then sent the suspect a total of \$4,800.00 before realizing it was a scam.
