## **Scams**

03.28 The grandson stated his grandmother was contacted by a person claiming to be with the Mega Millions and stated she had won a prize. They told grandma she needed to pay \$375 in order to get the prize. The grandson said the person is insisting that he is going to come to the house to give the prize today at noon. The grandson was advised they are not going to come to the house, but he could call us if he does observe anything suspicious. He was advised to contact his grandmother's bank and put a fraud alert on it.

04.02 The victim owns a construction business and was frauded out of \$65,000. He stated that on 3/31/2025, he was on his computer, and it went blank, and a message from Microsoft told him to call the number on the screen due to his computer being hacked. He called the number and spoke with a male who told him he would transfer him to a Wells Fargo contact to put his money into a safer account due to all his things on the computer being compromised. He said he spoke with a male who went by Sean Graft, who got him to wire transfer \$65,000 to what he thought was a safe bank account. He stated the next day he didn't feel right and went to the bank, and they stated he was scammed out of the money. He stated that they attempted to do a reverse wire to stop the money transfer, but it was unsuccessful.

04.03 The victim received a call on 04/01/2025, from a female claiming to be an employee from Wings Credit Union. The female stated that the victims account was used to make fraudulent purchases. She was instructed that a law enforcement personnel would contact her. She then received a call from a "Jason Webber" - (323-244-4877) on 04/03/2025. Webber stated someone had bought a smart phone to her account. He then instructed the victim to go take out \$40,000 from her account and send it to him, so he can keep the money safe. Luckily, the victim's realtor came over to her house today and informed her that this was a scam.
