FRIDAY UPDATE: 05.23.24

Scams

05.19 The victim received a message from Microsoft on her desktop computer the end of April. The message stated that her computer has been compromised and she should call a specific number for assistance. She called that number and spoke with a female who identified herself as Sarah with technology support. Sarah reported that the victim has multiple viruses, some containing pornography, and transferred her to Gary with the FCC. The victim communicated with Gary several times over the next week and eventually pulled \$13,000 cash from her bank. At the direction of Gary, she brought the money to a Holiday Gas Station in Anoka and deposited the full amount into a Bitcoin machine as payment to rectify the computer/legal issues she was having. Gary attempted to get an additional \$24,800 from her but she called a deputy first and found out this was a scam.

05.20 The victim received a call from a male claiming to be Sgt. Williams from Marion County Sheriff's Office in Florida. The victim has a son that frequents jails in Florida and has been to Marion County Jail before. 'Sgt Williams' claimed he needed to use Paypal or Zelle to accept payments. In total, through multiple payments, the victim lost \$2,310. He advised that he felt rushed by the people on the phone and felt pressured to make the payments. He showed the deputy Zelle transactions that were addressed to a Jordan Lott and an Angelique Valdez.

05.21 On 05/20/2025 the victim received a phone call from a restricted number with a male claiming to be a Sergeant with ACSO. She stated the male advised her that she failed to show up for federal jury duty and had a warrant for her arrest. She was advised that there was a fine attached to the warrant that she would have to pay or she would be arrested and put in jail. He attempted to get her bank account information but she refused to give it to him. He advised her that she needed to go pull \$2,000 from her bank account and deposit the money into a Bitcoin Depot ATM. The victim went to a Bitcoin ATM in Anoka and deposited \$2K using the QR code the suspect texted her. She was told to go buy pre-loaded gift cards and send pictures of the back of them which she did. The victim stated that she was told to go to ACSO and wait for a handwriting expert because she was told if she didn't sign the jury duty paperwork, then she may be involved in a scam. She stated that she waited at ACSO for two hours before texting the suspect asking what's up and he replied that if she wanted her money back, she had to send a picture of her private parts. That is when she knew it was a scam and wanted it reported.

05.21 The victim stated he received a text message from someone claiming to be from Wells Fargo asking him if he made a large transaction at Target and he told them no. He got a response back with someone claiming to be from their fraud department telling him he needed to transfer all his money into a safe account they had created so they could investigate the fraud. He went to his bank and took money out of his account and transferred it to the google pay account they told him to send it too. He stated the tellers questioned what he was doing, but he was warned by the male claiming to be with Wells Fargo that it was an inside job and to not listen to them. He went through with the transfer and later found out it was a scam. Unknown loss.

05.21 The victim stated that he received a phone call from Anoka County Deputy Brian Collier in regard to paying a \$1500 fine to avoid a contempt of court charge. He was directed to go to Walmart in Blaine and make two \$750 wire transfers. Failing to do so would result in a warrant for his arrest. The victim made the transfer. He was later advised that he owed an addition \$500 court fee. At this point he caught on to what was happening and tried to get the transaction reversed but was unsuccessful. He is out \$1500.

- 05.21 14600 Block Round Lake Blvd NW DWI 4th degree; a deputy stopped a driver for speeding 59/45. The driver appeared impaired and stated she was at a party and had a drink. Field sobriety tests were failed. She was arrested. .15
