Scams

07.23 The victim stated she was contacted by a woman who identified herself as Suzanne Clark from US Banks Fraud Department and called using phone number 1-800-872-2657. She stated Clark told her they were suspecting an employee of theft and that her information had been compromised. Clark asked her to withdraw \$6,600 from her US Bank account and stop in at the Chase Bank, located in Roseville and use the ATM in the lobby to secure her funds onto a debit card. The deputy asked what the debit account information was, and she stated she uploaded it into her apple wallet but after the transaction she was told to delete it and now doesn't have the information anymore. The victim stated this person now has her money and access to her social security number, email, and personal identifying information.

07.23 The victim stated that on 6/24/25, she received an email from an unknown email address stating that she had the opportunity to purchase a vacuum for a discounted rate \$11.97. The email address appeared as though it was from Target and she had recently purchased the same vacuum for full price. She completed the transaction using her Target Credit Card. She printed out a confirmation. On July 17th, she noticed a second charge of \$76.42, from the same company, Elite Craft Uniforms D HUNTINGTN BCH CA, on 6/28/25 that she did not authorize. She reached out to Target and flagged the purchase as fraud. Target began an investigation and recently asked her for the case number for local law enforcement.

He didn't speak English so the language line was used. Field sobriety tests were failed. He was arrested. .143

When the deputy made contact, he smelled marijuana and a joint was seen in the cup holder. He stated he had smoked the day before. The driver did not have a license or proof of insurance. He provided a passport. His DL was revoked. Field sobriety tests were failed. A warrant for blood was obtained. He was arrested.

The driver did not speak English, so the translation line was used. Field sobriety tests were failed. He refused the official test and was arrested. He provided a weak sample of .11

07.19 Pierce/Bunker Lake Blvd NE – DWI 3rd degree; a deputy responded to assist a Reserve Deputy who was dealing with difficult person. The male was intoxicated. The male had come to the location in his work van. His parents were on scene trying to help and confirmed he drove there. Field sobriety tests were started but could not be completed due to intoxication. He was arrested. .18
