## **Scams**

11.13 Deputy Knight was dispatched to a fraud report. The victim stated that over the past month he has been taking money out of his Blaze bank account and depositing it into the coin base server to invest the money in crypto currency. He stated that he bought \$5000 worth of crypto from "Keex Pro". He stated that yesterday he was talking with his banker at Blaze, and they informed him that the crypto service was a scam. He stated that he has been trying to get in contact with the company via text message (1-318-482-4252) and believes they might send him \$3000 dollars back. However, he was not entirely sure they would. He stated he also was required to send the company a photocopy of his driver's license.
