### **Scams**

# Andover

#### Thefts & Damage to Property

01.06 21xx Andover Blvd NW – window broke on a vehicle in the school parking lot; nothing taken

#### Arrests

01.11 14700 Block 7 Ave NW – No Contact Order Violation; a deputy stopped a driver for having a headlight out. When he made contact, the driver provided the documents the deputy needed and he ran the male; all was good. When he returned to the vehicle, the male showed the deputy a no contact order paper and the woman who had the order against him was in the passenger seat. He was arrested.

Field sobriety tests were conducted and failed; she PBT'd .274. She was arrested. When asked to take the official breath test, she stated she wouldn't because she was a smoker.
