# FRIDAY UPDATE: 11.19.21

# Scam

On 11/12/2021 at 1626 hours, I was dispatched to call for a fraud report. The reporting party reported that she met a male on Snapchat that gave her the name Tony. The RP said that Tony sent her a check for \$3,500 with instructions to deposit the check and send \$2,000 to his daughter via Apple pay. The RP said that on Monday (11/08/2021) she deposited the check in her account via Mobile deposit. The RP stated on Tuesday (11/09/2021) she sent the \$2,000 in Apple pay. The RP then learned from her bank, Huntington, that the check is bad and her account has been closed due to fraudulent activity. She then told me that she still communicates with Tony, and Tony sent her another check for \$4,500 with instructions. The RP told Tony that she sent the \$2,000, but was unable to send the \$1,000. She then advised that Tony now is pretending to be an FBI agent. I advised her that this is a common scam and to discontinue communicating with Tony. I then asked the RP if she is out any money. She did not know at this time if she needs to cover the \$2,000 loss that she sent via Apple Pay. I then provided her with my name and case number for this incident. I advised her to contact her bank and see if she needs to cover the loss. I also asked the RP to print out any communication/messages between her and Tony and call me back.

On 11/16/2021 at 1416 hours, I was dispatched a phone call report regarding a suspicious phone call. Upon calling I spoke with the reporting party who advised that she had received a phone call from a patron who advised that she had just received a scam call regarding a car warranty however the phone number listed on the call appeared as if it was coming from Oak Grove City Hall. The RP just wanted to make us aware that people are receiving phone calls that appear as if they are coming from the City Hall. NFI, Clear

On 11/17/2021 at 1653 I was dispatched to an attempted fraud report. The Rp advised that she just received a phone call from an unknown person who stated that they were from Twin City Federal. The RP was then asked if she made a purchase from Amazon for shoes. The RP stated that she did not make a purchase and the unknown caller then asked her to log into her computer. The RP stated that she hasn't used it for a long time and was unsure of how to log in. The RP began to realize that this was a fraud call and she hung up on the unknown person. No suspect information was available, and I cleared with no further actions taken.
