**FRIDAY UPDATE: 11.25.22** 

#### **Scams**

11.18 The caller stated that her son added an unknown person on Snapchat who he thought was a female. She stated that he realized it was not a female and it is an unknown male. She stated that the male is messaging her son saying that he needs to pay \$150 otherwise the male would post an inappropriate photo of him on Facebook. The mother also stated that because her son's location was on, the male was able to see where they live. She also stated that the male is messaging through an unknown email address. She asked me what they should do and I advised them to block and delete the contact on Snapchat and his phone.

- 11.19 Facebook Fraud: The victim stated that she saw a job offer on a Facebook swap site and she contacted them through email and the telegram app. She filled out a W2 form, had interviews, and gave other personal information through the contacts. She realized that it was a scam after people started posting on the original Facebook post about their experiences. She wanted to know what she should do due to her giving out so much personal information including her social security number. I advised her to put a credit freeze on her credit score and to change the passwords for all of her sensitive information. I also advised her to monitor her banking information and to notify LE if anything is found missing or changed. She had not given any money to the scam at this time, only personal information.
- 11.20 The victim advised me that he signed up through a link on Instagram to win \$200,000.00. He stated that he received a phone call from 141-590-0411 and was advised that he won the grand prize. The person told him to send him \$400.00 in Amazon Gift Cards in order to collect his grand prize. He informed me that he purchased the gift cards and sent them the card numbers. He concluded that this was a scam and told the person that he contacted the sheriff's office. The victim informed me that he is now getting threatening messages. I advised him to contact his bank and to block the phone number.
- 11.21 Instagram Blackmail: The victim started a chat with someone on Instagram. He believed this unknown person to be someone who was sexually interested in him. Their chat became sexual in nature and the other person began a video chat with him and an inappropriate video was captured. A short time later, the victim received an Instagram message from someone with the handle @denise.wood115 and the name of "Denise Wood." "Denise" sent the victim the video she had taken. She said he needed to pay "her" \$2500 or "she" would disseminate the video to his friends and upload it to YouTube to "ruin his life." Denise claimed "her" mother had cancer and "she" needed the money to pay for an operation. "Denise" started a countdown and because he did not pay the money, "she" started a group chat with a number of his Instagram friends. "Denise" sent the video to the group chat. I explained to him that this was a common scam, and he said he did not send any money. I told him to block the account and delete his Instagram account.

- 11.21 The victim stated that a recruiter for a company called Boll & Branch wanted to hire her. She said that the recruiter, James Lacey, at 508-350-3095, stated that he needed to send her \$1,699.98 to buy computer equipment. She stated James requested that she provide his driver's license information and Wells Fargo bank information. She advised that Wells Fargo has opened a new account for her. I advised her to call the credit bureaus to report the scam and their identity possibly being stolen.
- 11.23 The victim called to report he was being extorted for money over nude photos he had sent to a Snapchat account. He said he received pictures from a female over Snapchat account "rhode\_gahallaga". He sent back a picture. He then received a long paragraph explaining the account holder had his genital picture and was going to disseminate them over social media to all his friends if he did not send him \$300. He spoke over the phone via Snapchat with the account holder, who had a thick Indian accent. The male had him attempt to send \$300 via CashApp, Zelle, gift cards, etc. The victim's bank would not allow the transactions to go through because he had previous strikes on his card that prevent large purchases. The male told the victim to have the payment completed by 0930 or he would disseminate his pictures to all of his Instagram followers. I told the victim not to send any money, as they would just keep asking for more. He said he would post a message to his social media about it being hacked.
